In addition to a fleet of over 100 service trucks, Action Environmental owns more than 80 pieces of specialized equipment including vacuum trucks, liquid vacuum trucks, service equipment, tractors and winch trucks, dump trucks, bob tail roll-off trucks and jetter trucks, as well as more than 20 pieces of construction equipment including excavators, front end loaders, skid steers, back hoes, road trucks and several drilling rigs.

## SAFETY AND TRAINING

From our new hire regulatory training programs to our advanced level training and in-house train-the-trainer programs, we are committed to the safety of our employees. As applicable, employees also receive the Federal Railroad Administration (FRA)'s Roadway Worker Protection Training, Operator Qualification Training for pipeline personnel, permit required confined space entry training, and confined space rescue training.

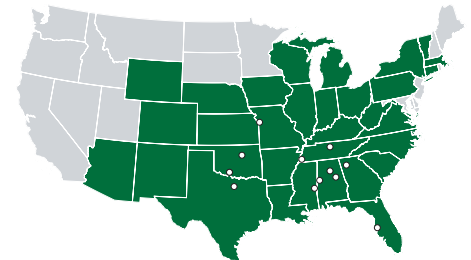
